- Complete at least 45 hours of family law-specific continuing education every three years
- Have favorable evaluations from peers and judges

#### Services

#### **Dissolutions**

We offer a full range of services relating to the dissolution of marriage and domestic partnerships. Our attorneys have extensive expertise in handling all aspects of family law including child custody and visitation, asset/debt division, child support, spousal/partner support, and nullity proceedings.
