PRACTICE OVERVIEW

Catharine Baker is a former California State Assemblymember who represented the 16th Assembly District from 2014 through 2018. She is a Commissioner with the California Fair Political Practices Commission, which administers and enforces California's landmark government ethics laws. Catharine is Special Counsel at Hoge Fenton, where she advises businesses and non-profits and practices election law.

BACKGROUND

During her legislative tenure, Catharine was an independent, bipartisan voice in the Legislature, fostering breakthroughs in significant legislation, particularly on transportation, the environment, and government accountability. Her collaborative leadership made her one of the most effective members of the Assembly. In just four years, sixteen of her bills — all supporting education, transportation, public safety, and government efficiency — passed the Legislature with bipartisan support, and all sixteen were signed into law. Significant legislation included the creation of Valley Link to construct a commuter rail connection between the Central Valley and Bay Area, more admissions opportunities to the University of California for California residents, and greater transparency and accountability rules for state and regional agencies.

Catharine is an active non-profit leader, serving on the boards of California Forward, California Women Lead, the Livermore Lab Foundation, and the Diablo Regional Arts Association and as a board advisor with Three Valleys Community Foundation. Catharine is a regular host on Tri-Valley Television for monthly episodes of Mayor's Report with local mayors and Supervisor's Report with Nate Miley.
